

Privacy Policy

1. Introduction

This privacy policy ("Privacy Policy") governs your use of the software and services of PHANTOM.ME, an app for Android mobile devices, which operates as a secret hidden zone offering users' privacy with respect to their digital activities (the "Application").

In this Privacy Policy we describe how we handle your Android mobile device information, including but not limited to, messages, photos, videos, documents, contacts, web content, third party applications ("Data"), while you use our Application

2. Sharing Data

We never share your Data with anyone. Not ever.

3. Storing Data

All Data is stored and encrypted locally on your Android mobile device. We only store the data we need in order for the Application to function properly — and for as long as you want the Application to function.

The Data is encrypted and is intended to block third parties from gaining access to the Application and/or the Data. The Application is secured with a password personally selected by you.

We do not store your Data on our servers or anywhere else. We also do not keep any logs for messages and/or phone calls and/or any information whatsoever. We have no way of knowing when or how you've accessed the Application and/or used the Data. This also means that we do not have a record of your password, and if you lose or misplace the password, we cannot assist with retrieving it and/or the Data.

4. Security

We have a team dedicated to keeping your Data secure in the Application and testing for vulnerabilities. We also continue to work on features to keep your Data safe in addition to things like authentication and encryption.

Neither Phantom.me, nor any of its affiliates, officers, agents, shareholders, directors and employees, make any specific promises and/or commitments regarding the Application and/or Data, including but not limited to, the functions, reliability, availability, or ability to meet your needs.

Please proceed with caution to this extent.

If you stop using PHANTOM.ME and do not login for at least 6 (six) months, your Application account can self-destruct and all Data that you've stored can be deleted permanently. Y
